1. The Name of the Trust shall be "**GURUKRIPA SEWA SANSTHAN**" At – Choudhary Tola, Ward No. – 12, P.O. & P.S. – Kahalgaon, District - Bhagalpur.

2. The trustee shall be a life member trustee.

3. The sole objects of the trust are as here under:-

a) To establish, maintain, manage and to grant aid in cash or kind to any of such school(s) for the welfare of children and in hospital, medicine, nursing institution and for sanctioned charitable and/or traveling dispensaries, minority homes, children care home, children welfare centre, widows and old age homes and or any other institutions for the benefit of public in general, more particularly for the welfare and education of the children and females.

b) To acquire land/building either on lease/rent basis or otherwise, including on purchase etc. as the case may be within the Indian territories, more particularly at Kahalgaon, at Bhagalpur District and also within the state of Bihar, Jharkhand and other states, with a view to establish and run a school/schools therein and to impart education to the people at large, including the people of poor, weaker, female and children section.

c) To establish, support, maintain, acquire, run and to accept grant and/or aid and other financial assistance for **PATHSHALAS, SCHOOLS, COLLEGES, LIBRARIES, READING ROOMS, HOSTEL,**

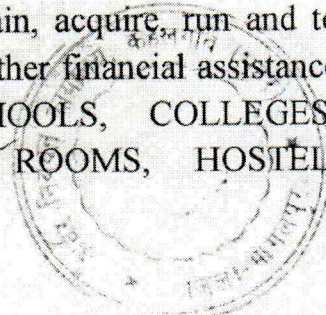

- d) To establish, maintain and provide student scholarship and to grant aid to needy pupils, including supply of books, stipends, medals etc and also to grant aid to orphanages, old people, widows etc.
- e) To provide relief during natural calamities to the victims and also provide medicine and nursing to them from time to time.
- f) To render assistance and/or aid to recognized public charitable trust or institution.
- g) To promote, organize and undertake programs for moral and mental development of women, youth and children of all communities, through seminar, meeting, debates, conference & workshop and also for the purpose of spreading awareness among the people in general from time to time and also to promote true, real and fair communications, publication, cultural and other welfare programme sponsored by private, public sector and also by central & state Govt.
- h) To establish Health Centre, Physical Education Centre, Maternity Centre, Blood Donation Centre, Eye Centre, Blind-School, Vaccination Centre, Family Planning Centre, Leprosy Centre, Drug addict Centre and to spread awareness about AIDS, Kalazar and other diseases from time to time among people in

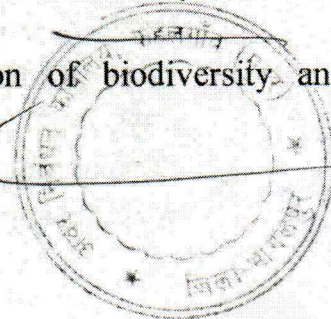
- i) To plant trees beside the road and vacant land for protection of environment and pollution control and spread knowledge about nonrenewable energy, solar energy, hydel and wind energy etc. in the society.
- j) To set up a frame work for alternative schooling for 6 to 14 age group child, not getting mainstream primary school education.
- k) To provide all kinds of facilities to the students and children in music, dance, drawing, painting, games, sports, Judo & Karate, Yoga, arts etc and all other possible programs for the benefit of the society at large nationality and integrity.
- l) To cooperate with the other organization having similar aims and interest and also provide opportunities for communication in between themselves.
- m) To do any other act for achievement and advancement of general public interest without discriminating on the ground religion, race, caste, colour & sex.
- n) To do all such things as may be deemed necessary by the Board of Trustee of the Trust from time to time in attainment of the objectives and programs, schemes introduced by the govt. or private authority.
- o) To work for the protection of biodiversity and environment.

4. The Trustees shall cause a true and correct accounts to be kept of all money received and spent and/or all materials, income and expenditure incurred thereof in course of the management of trust fund and in relation to carry out the object and purpose of the trust as well as of all the aspects of the trust fund.

5. For all furthering of objects of the trust, the trustees will have the following powers, which will be exercised by them in accordance with the provisions of Income Tax Act 1961 and the Income Tax Rules 1962 as amended from time to time.

a) To accept any donation, contribution, grant and subscription for the trust.

b) To invest and keep invested the trust fund for purchase of immovable property, including Agricultural, house hold and Flat etc. or in share/mutual fund and stock or debenture and in any other securities and investments whether authorized by the Indian Trust Act 1882 or not or in deposit with any company, firm, Bank and/or on any other person in conformity with the provisions of Income Tax Act for the time being in force and alter, vary or transpose such investments from time to time as the trustees may in their sole discretion think fit for the same or like or different nature.

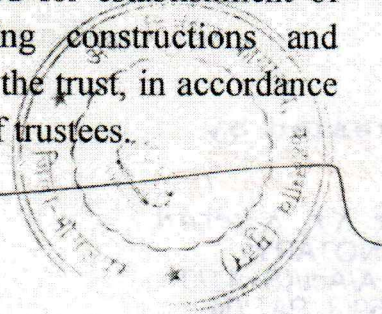
c) To borrow or secure payment or money and also to lend money either with or without security.

d) To accept/obtain loan (C/Credit, T. Loan, O/D, Housing and other type of loan in nature) from any nationalized Bank & from any other financial institutions and any other private agency, if required for establishment of any type of work(s), building constructions and developments for the benefit of the trust, in accordance with the approval of the board of trustees.

- e) To sell, dispose off or transfer any right in the movable and immovable property, comprising the trust fund, beneficial and in the interest of the trust.
- f) To open A/c or A/c(s) with any Bank in the name of the Trust, and operate the same by one or more trustee or by appointed agent as the trustees in its board meeting decides from time to time with due information to the Bank.
- g) To pledge and mortgage the lease property or any other movable & immovable property with the Bank by way of security, to secure any loan amount there from for the purpose of the trust.
- h) To appoint constituted Attorney or agent and to delegate any such powers to them for ever or for any of the period vested with them.
- i) To start, abolish, discontinue and restart any charity or charitable institution, organization for the benefit of general public and to grant and to pay any amount for its improvement and development, either by subscription or donation or in any other form.
- j) To join/merge and cooperate this trust with others, having allied objects upon such terms and conditions as trustees may decide in its board meeting in their discretion and nature of the trust.

6. Subject to such rules & regulations, the trustees may from time to time do the following acts, deeds and things:-

- i) To make, vary, alter and modify any such scheme(s), rules and regulations for carrying out or to be carried out by the trust in accordance with the objects of the trust and to its management and affairs and for running

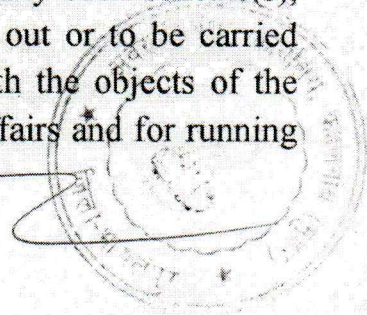

any institution in furtherance of the objects of the trust and otherwise for giving effect to the object of the trust.

- ii) To start, abolish, discontinue and restart any charity or charitable institution, organization for the benefit of general public.
- iii) To set apart or accumulate the whole or part of the income or the corpus of the trust fund or part thereof and any amount of subscription or donation what so ever may be.
- iv) The receipt, payment or pension authorized by the trustee in a resolution of the Board of trust for any money paid or any property transferred, delivered or to be delivered, must be approved by the Board of trustee.
- v) The Trustee will not be entitled to receive any of the remuneration, but may reimburse themselves of all expenses actually incurred by them in connection with the Trust or their duties relating thereto. However trustees shall also be entitle to receive salary @ as decided in the Board meeting from time to time, in case they devote their whole time for the execution and welfare of the trust.

7. The number of the trustee shall not be less than two or more than five.

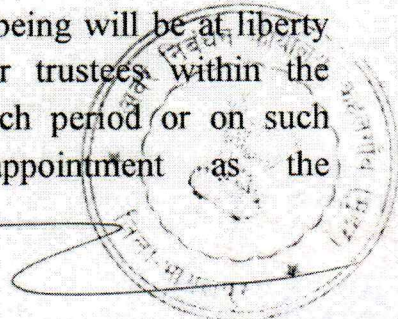
The trustees named herein above in this trust, including the Settlor shall be called/treated as lifelong trustees for the trust.

trustees for the time being consider proper in its Board Meeting and by $\frac{3}{4}$ th majority.

If any trustee dies, retires, become unfit or incapable to act in continuing so, the remaining trustee shall be competent to appoint a trustee in his place to act in a board meeting of the Trust. Every Trustee shall have liberty to resign, on giving one month notice regarding his/her above said intention to the Trust.

It may be clear here, that on the death, retirement, unfit or incapability of any of the life member trustee named as trustee in this deed, in his/her place only his/her one family member shall be appointed or substituted as trustee in his place not any other person.

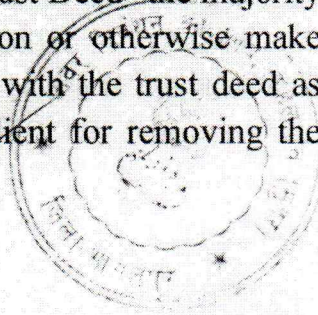
On the basis of such regulations :-

- a) At least two Trustees shall form a quorum for the purpose of the trust.
- b) All matters will be decided in the Board meeting by $\frac{3}{4}$ th majority.
- c) Resolution passed without any meeting of the trustee shall not be valid.
- d) The trustees shall have power to amend, alter or rescind the rules and to interpret their meaning whenever the rules and by laws framed do not cover any emergency or any ambiguous provided that such change or interpretation does not conflict with the aims and objects of the trust. If any difficulty arises in giving effect to the provisions of the "Trust Deed" the majority of the trustees, may by circulation or otherwise make such provisions not inconsistent with the trust deed as appear to be necessary or expedient for removing the

difficulty and shall follow the same, by confirming and approving it in two special general Board meetings.

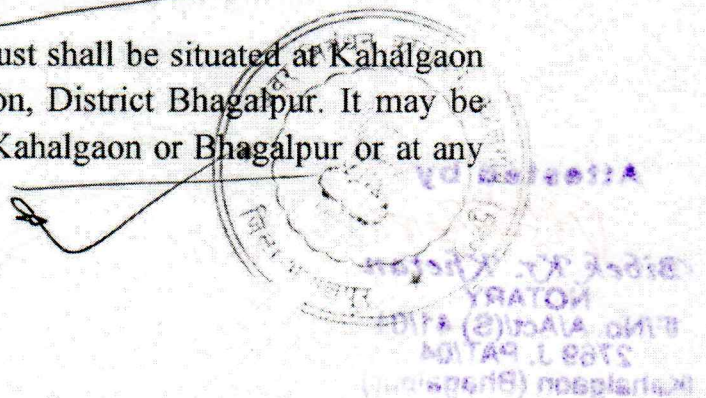
- e) The secretary or chairman of the trust shall remain the Settlor of the trust and after his retirement, death and incapability his family member shall be appointed as secretary/chairman of the trust and the same shall be continued.
- f) That the trustees are not related with each other as provided in the Trust Act.
- g) The Settlor/chairman of the trust shall be at present manager and head of the school already run by him and shall manage the trust with the help and aid of the other trustees.
- h) That the trustees shall be the member of the school managing committee and two parents of the student and two teachers of the school shall also be the member of the said committee and if required any other required person or women shall be also nominated as member of the said committee. The said managing committee shall discharge all the function of the school under the supervision and direction of the head of the institution properly.
- i) The said managing committee shall have all the powers to appoint teachers, other employees as required from time to time and terminate his/their services in its meeting and shall do all such necessary acts as required from time to time to run the school(s) etc.

8. The head office of the Trust shall be situated at Kahalgaon Thana Road, Kahalgaon, District Bhagalpur. It may be changed at other place at Kahalgaon or Bhagalpur or at any

other place within the State of Bihar, Jharkhand and others for the proper management and benefit of the Trust.

9. The accounting year of the Trust shall be treated from the 1st April to 31st March of every year, and the same may be changed in the Board meeting by the trustees. The accounts of the Trust shall be checked and audited as applied for the time being by the recognized Income Tax practitioner or chartered accountant and the same be verified and checked also by any other concerned authority, if so required at any time during the office hours and their fees etc. shall be borne by the Trust.

10. That it is expressly declared that no part of the Trust property or its income shall be applied for any other purpose save and except those that are mentioned here in above, either within India or abroad or for any other purpose not accepted by law and all provisions hereby shall be construed accordingly.

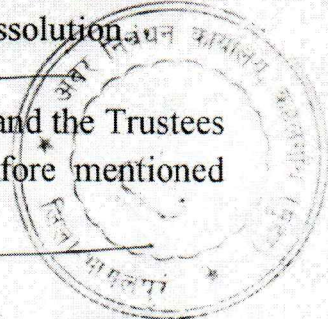
11. Any addition, alteration or omission in the objects and rules regulations of the Trust shall be affected by the resolution of the trust in its Special Board meeting approved by $\frac{2}{3}$ th majority.

Before dissolution of the Trust, the State Government consent will be obtained under the Trust registration Act. & after dissolution any remaining property movable or immovable, after settlement of all debts and liabilities, the property so left shall be distributed among the members of the Trust or shall be given to some other trust or society or to any other concerned trust, organization, to be determined by the votes of not less than $\frac{3}{4}$ th member of the trust present in person at the time of dissolution.

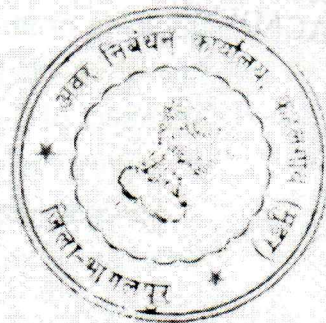
